AN ORDINANCE OF THE CITY OF SIOUX FALLS, SD, AMENDING THE CODE OF ORDINANCES OF THE CITY BY AMENDING SECTION 41.008 REGARDING FEES FOR PUBLIC FACILITY TICKETS.

BE IT ORDAINED BY THE CITY OF SIOUX FALLS, SD:

*Section 1. That Section 41.008 of the Code of Ordinances of Sioux Falls, SD, is hereby amended to read:*

Section 41.008. ~~FEES FOR TICKETS~~ PUBLIC FACILITY TICKET FEES.

The following Public Facility Ticket fees shall be charged for tickets on all paid admissions to events at ~~the Sioux Falls Arena or Sioux Falls Convention Center and all city-owned~~ sports or entertainment facilities having a fixed seating capacity in excess of 2,500 persons, ~~other than facilities owned by any school district, county or non-profit educational or religious institutions:~~

- (a) Fees for season tickets sold ~~for any season beginning in 2004 by the Sioux Falls Canaries baseball team until Oct. 1, 2015 for professional sports teams with agreements for season use of the facility:~~

\$11.99 or less	\$0.25 per ticket
\$12 or more	\$0.50 per ticket

- (b) Fees for season tickets and any other tickets sold ~~for seasons beginning in 2005 and thereafter,~~ for professional sports teams with agreements for season use of the facility:

\$11.99 or less	\$0.50 per ticket
\$12 or more	\$1 per ticket

- (c) Fees for all other admissions shall be established by the facility operator after consultation with the City Finance Director. The fee shall not exceed \$3.00.±

(d) The fees shall be collected by the operators of the facilities and remitted to the city within 60 days of receipt and deposited in the General Fund of the City unless directed otherwise in the management agreement or lease. ~~Fees collected shall be deposited in the general fund of the city.~~
