### What are Tax Incremental Financing (TIF) Districts?

- TIF is an incentive utilized by the City to stimulate private development and investment.
- TIF can help retain existing businesses that might otherwise find more attractive options elsewhere.
- TIF helps to overcome the extraordinary costs that often prevent redevelopment and private investment from occurring in difficult to develop or blighted areas of the community.
- TIF may be used to attract special projects that bring significant economic growth and impact to Sioux Falls.

# History of Tax Incremental Financing

- Private entities often times approach the City with project ideas or business plans. When those projects have unique challenges, TIF may be requested and considered.
- The City of Sioux Falls established its first Tax Incremental Financing (TIF) District in 1989.
- To date, the City has approved 20 TIF districts.
  - o 15 within Downtown
  - 5 in other locations
  - o 13 are "active"
