2. Land Use Committee

A. Meeting of Tuesday, June 16, 2015

Committee Chair Rick Kiley presented an update on the meeting held on Tuesday, June 16, 2015, regarding the discussion on proposed changes to the ordinances regarding off-sale alcohol sales.

3. City Council Open Discussion
