RESOLUTION NO. 40-17

A RESOLUTION ADOPTING THE JOINT CITY OF SIOUX FALLS/LINCOLN COUNTY 2040 COMPREHENSIVE PLAN.

WHEREAS, the Joint City of Sioux Falls and Lincoln County Planning Commissions have proposed a plan for the physical development of the joint jurisdictional area within the approved joint planning jurisdictions;

WHEREAS, the Joint Lincoln County and Sioux Falls Planning Commission held a public hearing on October 12, 2016, to gain input from the public;

WHEREAS, the Joint Sioux Falls City Council and Lincoln County Commission held a public hearing on April 25, 2017, to gain input from the public;
WHEREAS, the comprehensive plan shows the Joint City of Sioux Falls and Lincoln County Planning Commission s recommendations of guiding and accomplishing a coordinated, adjusted, and harmonious development of each joint planning jurisdictional areas, which will, in accordance with existing and future needs, best promote health, safety, morals, order, convenience, prosperity or the general welfare, as well as efficiency and economy in the process of development;
