1. Call To Order

- 2. Staff Report
- A. Jim David, Legislative/Operations Manager

Jim David, Legislative/Operations Manager, presented an update on the current legislative session including HB1106,SB173,HB1131,and SB135. David presented PowerPoint slidesto further clarifySB135,Temporary Penny for Infrastructure.

- A. Premier Center Ticket Sales by Terry Torkildson, Denny Sanford Premier Center General Manager

Terry Torkildson, General Manager of the Denny Sanford Premier Center, gave a PowerPoint presentation including slides entitled: Why Do Some Shows Sell Out So Quickly; Supply and Demand; What is the Premier Center's Role in the Ticketing Process; What is a Presale and How Does It Work; Presales: Who Gets Access; Why Are Tickets Listed on StubHub and Other Sites; Advice When Buying From or Selling on Reseller Sites; Ticket Buying Tips.
