WHEREAS, the Sioux Falls City Council serves on the South Dakota Municipal League's policy committees and supports the League's 2019 Statements of Policy;

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF SIOUX FALLS, SD:

1. The Sioux Falls City Council supports a reliable statewide emergency radio system that allows users across the state to communicate within and outside of their agencies. In order to sustain this capability and enhance operations locally, statewide, amongst other states, and with federal agencies, the City Council supports state funding initiatives to upgrade the

statewide system to the national standard for public safety communications utilized by both federal and state governments known as Project 25 (P25).

- 1. The Sioux Falls City Council supports legislation allowing alternative publication options for local government.
- 1. The Sioux Falls City Council supports legislation providing county commissi ons the option to reduce the number of official newspapers to one.
- 1. The Sioux Falls City Council supports legislation that expands workforce ho using opportunities in South Dakota.
